## Oglethorpe COVID-19 Task Force Campus Protection Guide

This document is intended to establish campus planning framework and provide a guiding resource for the community. Complete and up to date formal policies for university activity can be found in the COVID-19 Handbook.

The university will announce the anticipated phase ahead of each semester; however, phases are subject to change due to the dynamic nature of the pandemic. The COVID-19 Task Force, in consultation with the President and the university's public health consultants, will make ongoing assessments based on both campus and community transmission rates. When there is a differential in campus and community rates, a hybrid of phases may apply.
